**CLINTON FIRE DEPARTMENT MILLAGE RENEWAL**

Shall the Township of Clinton, Lenawee County, Michigan, for the purpose of fire department operation, maintenance and improvement, establish and authorize the renewed millage levy not to exceed 1.6 mills on taxable value of property, including property subject to Industrial Facilities Exemption Certificate (IFT) located in the Township of Clinton (\$1.60 per \$1,000 taxable value), for a period of eight years from 2020 through 2027 inclusive, and when necessary to do so, exceed the fifteen (15) mill limitation on general ad valorem taxes imposed under the Michigan Constitution-Article IX, Section 6, which will raise in the first year of the levy an estimated \$184,000.

**HILLSDALE COUNTY INTERMEDIATE SCHOOL DISTRICT  
AREA CAREER AND TECHNICAL EDUCATION PROPOSAL**

Shall Hillsdale County Intermediate School District, Michigan, come under sections 681 to 690 of the Revised School Code, as amended, and expand an area career and technical education program, which is designed to encourage the operation of area career and technical education programs, if the annual property tax levied for this purpose is limited to .6082 mill (\$0.6082 on each \$1,000 of taxable valuation) for a period of 20 years, 2020 to 2039, inclusive; the estimate of the revenue the intermediate school district will collect if the millage is approved and levied in 2020 is approximately \$703,332 from local property taxes authorized herein?

**SAND CREEK COMMUNITY SCHOOLS  
OPERATING MILLAGE RENEWAL PROPOSAL**

This proposal will allow the school district to continue to levy the statutory rate of not to exceed 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its full revenue per pupil foundation allowance. The remaining .3168 mill is only available to be levied to restore millage lost as a result of the reduction required by the "Headlee" amendment to the Michigan Constitution of 1963 and will only be levied to the extent necessary to restore any reduction.

Shall the currently authorized millage rate limitation on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in Sand Creek Community Schools, Lenawee County, Michigan, be renewed by 18.3168 mills (\$18.3168 on each \$1,000 of taxable valuation) for a period of 8 years, 2021 to 2028, inclusive, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and 18 mills are levied in 2021 is approximately \$430,650 (this is a renewal of millage that will expire with the 2020 tax levy)?

**SAND CREEK COMMUNITY SCHOOLS  
SINKING FUND MILLAGE RENEWAL PROPOSAL**

This proposal will allow the school district to continue to levy the building and site sinking fund millage that expires with the 2020 tax levy.

Shall the currently authorized millage rate of 1.8414 mills (\$1.8414 on each \$1,000 of taxable valuation) which may be assessed against all property in Sand Creek Community Schools, Lenawee County, Michigan, be renewed for a period of 8 years, 2021 to 2028, inclusive, to continue to provide for a sinking fund for the purchase of real estate for sites for, and the construction or repair of, school buildings, for school security improvements, for the acquisition or upgrading of technology, and for all other purposes authorized by law; the estimate of the revenue the school district will collect if the millage is approved and levied in 2021 is approximately \$257,000 (this is a renewal of millage that will expire with the 2020 tax levy)?
