**RAISIN TOWNSHIP PROPOSAL**

**RAISIN CHARTER TOWNSHIP ROAD MILLAGE PROPOSAL**

Shall the limitation on the amount of taxes which may be imposed on taxable property in the Charter Township of Raisin, County of Lenawee, Michigan, be increased by .95 mills (\$.95 per \$1,000 of taxable value), for a period of five (5) years, 2021 to 2025, inclusive, as new additional millage to provide funds for road improvement purposes? It is estimated that .95 mills would raise approximately \$255,036 when first levied in 2021.

**WOODSTOCK TOWNSHIP PROPOSAL**

**RENEWAL OF FIRE MILLAGE**

Shall the expired previous voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution in the Township of Woodstock of 0.75 mills (\$0.750 per \$1,000 of taxable value) be renewed up to 0.75 mills (\$0.750 per \$1,000 of taxable value) and levied for 3 years, 2021 through 2023 inclusive for the purpose of providing additional revenue for fire protection and prevention, which increase will raise an estimated \$148,782.36 in the first year the millage is levied?

**COLUMBIA SCHOOL DISTRICT**  
**SINKING FUND MILLAGE PROPOSAL**

Shall the limitation on the amount of taxes which may be assessed against all property in Columbia School District, Jackson, Lenawee, Washtenaw and Hillsdale Counties, Michigan, be increased by and the board of education be authorized to levy not to exceed 0.65 mill (\$0.65 on each \$1,000 of taxable valuation) for a period of 10 years, 2022 to 2031, inclusive, to create a sinking fund for the construction or repair of school buildings, for school security improvements, for the acquisition or upgrading of technology, and all other purposes authorized by law; the estimate of the revenue the school district will collect if the millage is approved and levied in 2022 is approximately \$470,124?
